Alice in Wonderland

**Issue: Did Alice disturb the peace and
commit theft under \$1000?**

Trial Procedure

1. The case starts when the sheriff calls "Order in the court. All rise." Everyone stands. The judge enters and takes his/her seat. Everyone sits down.
2. The court clerk calls the case "Regina versus _____(names of the accused).
3. The Crown and Defence lawyers introduce themselves to the judge.
4. The clerk reads out the charge (the indictment), and asks each of the accused, "How do you plead?"
5. Each of the accused answers "Not guilty."
6. The Crown makes an opening statement to the jury.
7. The Crown calls its first witness.
8. The defence cross-examines this witness.
9. Repeat the last two steps for each witness.
10. The Crown rises and says "That concludes the Crown's case, Your Honour."
11. The defence begins by making a short opening statement to the jury.
12. The defence calls its first witness.
13. The Crown counsel cross-examines this witness.
14. Repeat the last two steps for each witness.
15. Defence and Crown counsels each make a closing statement to the jury. The defence goes first, followed by the Crown.
16. The judge instructs the jury.
17. Jury leaves to decide a verdict.
18. Jury returns.
19. The court clerk asks for the verdict.
20. The judge lets the accused go free if the verdict is "Not guilty." If the verdict is "Guilty," the judge asks one Crown lawyer and one defence lawyer to speak to sentence. The judge then sentences the accused.
21. The court says, "Order in the Court." Everyone stands, the judge leaves and the trial ends.

Glossary

Trial: hearing before a judge, or judge and jury, to decide if a person has broken the law.

Verdict: finding by the court if a person is guilty or not guilty.

Evidence: information presented by lawyers during a trial i.e. witnesses, exhibits, etc.

Witness: person giving information during the trial.

Exhibit: object, such as a weapon or piece of cloth as part of the evidence used by lawyers to prove a case.

Sentence: punishment ordered by judge after accused is found guilty.

Judge: person who finds a person guilty or not guilty.

Jury: group of twelve people who find a person guilty or not guilty.

Crown Counsel: Crown lawyer for the government who has to prove that a person is guilty of breaking the law.

Defence Counsel: Defence lawyer who defends a person accused of breaking the law.

Accused: person suspected of breaking the law.

Court Clerk: Court person assisting the judge.

Sheriff: person who is like a police officer of the court whose job it is to maintain security in the courtroom.

TIPS

- Stick to the script although some improvisation can occur.
- Remember that witnesses cannot be asked to make statements on matters that they have not personally seen or heard.
- Crown and Defence Counsel should always stand when speaking.
- Always address the Judge as "Your Honour"
- Judge may ask other questions throughout the trial to clarify points, so lawyers should be prepared to answer these.
- Speak clearly!

Script

COURT CLERK/RECORDER: All rise, this court is now in session., His/her honour Judge _____ presiding.

(Everyone remains standing until the Judge tells them to be seated).

JUDGE: You may be seated. Are all parties present?

CROWN#1: *(stands and addresses the Judge)* Yes, Your Honour. The case of Regina vs. Alice in Wonderland. I am _____ and these are my friends _____ and _____. We are acting on behalf of the Crown. These are our learned friends _____, _____ and _____ acting on behalf of the accused. *(Each lawyer stands as he/she is being introduced.)*

JUDGE: Thank you. *(Lawyers sit.)* Please read the charge. *(To Court Clerk)*

(Alice, the Sheriff, the Defence Lawyers, and the Court Clerk stand. The Court Clerk reads from the indictment which the Crown Prosecutor now gives to him/her.)

COURT CLERK/RECORDER: Alice, you are charged that on, or about the 1st day of April, 2017, in Wonderland, BC, you did unlawfully cause a disturbance and have therefore been charged with "Disturbing the Peace," and did also commit the crime of "Theft under \$ 1000.00" of a box of Currant Cookies from White Rabbit's cottage. How do you plead?

ALICE: Not Guilty!

COURT CLERK/RECORDER: Your Honour, the accused pleads "Not Guilty."

(Those standing now sit down.)

JUDGE: *(to Crown)* Please proceed with your case.

CROWN#2: *(Opening Statement)* Your Honour, we intend to prove that Alice deliberately followed White Rabbit down the rabbit hole into Wonderland! She upset many of the citizens of Wonderland with her many requests for directions. Furthermore, she took food and drink which wasn't hers, and interrupted a Tea Party and Croquet Game without being invited! Finally, she stole a box of cookies from the home of White Rabbit.

CROWN#3: To support our case, we will be calling the Knave of Hearts, who was the arresting officer, White Rabbit, and the Queen of Hearts. We now wish to call the Knave of Hearts.

(The Knave of Hearts goes takes the stand. All Witnesses remain standing until they have been sworn in.)

COURT CLERK/RECORDER: State your name and address, please.

KNAVE: My name is the Knave of Hearts, and I live in Card Castle, in Wonderland, BC

COURT CLERK/RECORDER: Take the Bible in your right hand. Do you swear to tell the truth, the whole truth and nothing but the truth, so help you God?

KNAVE: I do.

COURT CLERK/RECORDER: Be seated, please. *(The Clerk returns to his seat.)*

CROWN#1: Knave of Hearts, please tell "The Court" what happened on April 1st of this year.

KNAVE: The Queen of Hearts was giving her weekly croquet party inside the castle rose garden. There was a disturbance, and she ordered me to break it up.

CROWN#1: What did you find when you went to break up this disturbance?

KNAVE: A young girl pushing over the Queen's soldiers and yelling "You're nothing but a pack of cards!" The flamingo mallets and hedgehog balls were scampering all over the field! The game was in ruin!

CROWN#1: Do you see the same little girl in the courtroom today?

KNAVE: Yes, that's her! *(He points to Alice).*

CROWN#1: The witness, the Knave of Hearts, has identified Alice as the girl in question. What happened next?

KNAVE: The Queen was very angry. She is used to winning every game. She was yelling "Off with her head!" So I arrested Alice and put her in the tower.

CROWN#1: Did you find any evidence?

KNAVE: Yes. I took her fingerprints, and they matched with the ones on the cards.

CROWN#1: Are these the fingerprint charts?

KNAVE: Yes, they have my signature on them.

CROWN#1: Court Clerk, please enter these charts as Exhibit A.

(The Court Clerk takes the charts).

CROWN#1: Thank you. No further questions, Your Honour.

(Crown takes his/hear seat).

JUDGE: *(To Defence)* Do you wish to cross-examine this witness?

DEFENCE #1: *(stands)* Yes, Your Honour. Knave of Hearts, were you present when this so called disturbance started?

KNAVE: No, I was in the castle..

DEFENCE #1: What were you doing in the castle when an important croquet game was being played?

KNAVE: I was locking up three gardeners who had been caught painting the roses red. The Queen was very angry with them. I didn't notice the disturbance until I returned.

DEFENCE #1: So, it is your evidence that you did not actually see Alice start the disturbance?

KNAVE: Well...no.

DEFENCE #1: In fact, I suggest that it was really you who started the disturbance in order to cover up the fact that you had slipped away to steal the jam tarts, which the Queen of Hearts had made

for tea after the game!

CROWN#1: *(jumps up and speaks angrily!)* Your Honour! I object!

JUDGE: Objection overruled. Witness, do you have anything to say?

KNAVE: I deny that I caused any such disturbance!

DEFENCE #1: I have no further questions, Your Honour.

JUDGE: *(to witness)* You may step down.
(to Crown) You may call your next witness.

CROWN#2: We call the Queen of Hearts, Your Honour. *(The Queen takes the witness stand)*

COURT CLERK/RECORDER: State your name and address, please.

QUEEN: *(haughtily)* I am the Queen of Hearts, and I live in Card Castle, in Wonderland, BC

COURT CLERK/RECORDER: Take the Bible in your right hand. Do you swear to tell the truth, the whole truth and nothing but the truth, so help you God?

QUEEN: I do.

COURT CLERK/RECORDER: You may be seated.

CROWN#2: Queen of Hearts, who usually attends your weekly croquet parties?

QUEEN: Each week I send special invitations to a number of lucky citizens of Wonderland. The guest list changes every week.

CROWN#2: And had you invited Alice to this week's game?

QUEEN: I most certainly had not! I'd never seen her before. She burst in on my croquet game uninvited. Why, she did not even have the good sense to let me win!

CROWN#2: How did the disturbance start?

QUEEN: Well, Alice could not seem to keep control of her flamingo mallet and hedgehog ball. Everyone was getting all mixed up, and she had the nerve to keep asking what the rules were! When she wouldn't even let me win, I finally shouted "Off with her head!" and my soldiers surrounded her.

CROWN#2: Did she leave peacefully?

QUEEN: No! She started shouting "You're nothing but a pack of cards!" and pushed the cards over, so my Knave of Hearts arrested her and took her to the castle tower.

CROWN#2: Thank you. No further questions, Your Honour.

(Crown returns to his/her seat).

JUDGE: *(To Defence)* Do you wish to cross-examine this witness?

(Defence rises and approaches the witness stand).

DEFENCE #2: Yes, Your Honour. Queen of Hearts, do you always win Every croquet game?

QUEEN: Of course.

DEFENCE #2: Don't you think it was reasonable that a little girl would get overexcited and confused when playing a game which had no rules?

QUEEN: Everyone else in Wonderland can do it.

DEFENCE #2: Don't you think that yelling "off with her head!" and locking Alice in the Tower, was rather drastic?

QUEEN: No! Especially since no one had invited her in the first place!

DEFENCE #2: No further questions, Your Honour.

(Defence returns to his/her seat).

JUDGE: *(to witness)* You may step down. *(to Crown)* You may call your last witness.

CROWN#3: We call White Rabbit, Your Honour. *(White Rabbit takes the stand)*

COURT CLERK/RECORDER: State your name and address, please.

WHITE RABBIT: White Rabbit, of Cozy Cottage, Wonderland, BC

COURT CLERK/RECORDER: Take the Bible in your right hand. Do you swear to tell the truth, the whole truth and nothing but the truth, so help you God?

WHITE RABBIT: I do.

COURT CLERK/RECORDER: You may be seated.

CROWN#3: Where were you going on April 1st, 2017, when you disappeared down the rabbit hole?

WHITE RABBIT: I was late for a very important date! I had forgotten my white gloves and fan, and was rushing home to get them before going to the Queen's Croquet Party.

CROWN#3: What happened when you noticed that Alice had followed you into Wonderland? Did you stop to speak to her?

WHITE RABBIT: *(shocked)* Oh my fuzzy ears and whiskers! NO!

CROWN#3: What did she do then?

WHITE RABBIT: Well! It was very annoying! She followed me through Wonderland, upsetting the little mice and birds by talking about her cat, Dinah, getting mixed-up in a Caucus race and complaining because it had no beginning or end, and scaring the flowers! They thought she was a weed!

CROWN#3: What happened when she finally caught up with you at your cottage?

WHITE RABBIT: She offered to go inside and run upstairs to my bedroom to get my white gloves and fan.

CROWN#3: And is that what she did?

WHITE RABBIT: No! She found a hidden box of very serious cookies, which I was saving for a special occasion, and ate them all up!

CROWN#3: *(holding up the cookie box)* Is this the empty box?

WHITE RABBIT: Yes!

CROWN#3: Your Honour, we would like to have this cookie box, which has Alice's fingerprints on it, entered as Exhibit B.

(hands the box to the Court Clerk then turns back to White Rabbit)

Would you tell the court what happened when Alice ate the cookies?

WHITE RABBIT: She grew so big that her head pushed up the thatched roof of my cottage, and she had to dangle her arms out of the bedroom windows. Her hands reached into my garden!

CROWN#3: How did you get her out?

WHITE RABBIT: Well, she pulled a carrot out of the garden and when she nibbled on it, she became tiny again, and ran down the stairs, out the door, and into the forest, without even saying she was sorry!

CROWN#3: Did you follow her?

WHITE RABBIT: Good gracious, no!

CROWN#3: When was the next time you saw her?

WHITE RABBIT: In the middle of a disturbance on the Queen of Heart's croquet field.

CROWN#3: Thank you. No further questions, Your Honour.

(Crown returns to his/her seat).

JUDGE: Does the Defence wish to cross-examine this witness?

DEFENCE #3: No, Your Honour.

JUDGE: *(to witness)* You may step down.

CROWN#1: We rest our case, Your Honour.

JUDGE: *(to Crown)* Thank you. *(to Defence)* Will the Defence please begin.

DEFENCE #3: *(Opening Statement)* We submit that this little girl, Alice, has been wrongfully accused of both crimes. She followed White Rabbit down the rabbit hole only because she was curious. She did not mean to upset the citizens of Wonderland, and joined in on their games and parties simply to be friendly. We will call Alice, Cheshire Cat, and the Mad Hatter as witnesses. I now call, the accused, Alice, to the stand. *(Alice takes the stand)*

COURT CLERK/RECORDER: State your name and address, please.

ALICE: Alice. I live at one hundred and eleven Curiosity Lane, Vancouver, BC.

COURT CLERK/RECORDER: Take the Bible in your right hand. Do you swear to tell the truth, the whole truth and nothing but the truth, so help you God?

ALICE: I do.

COURT CLERK/RECORDER: You may be seated.

DEFENCE #1: Alice, what were you doing on the afternoon of April 1st, 2017?

ALICE: I was sitting under a big oak tree in our yard, with my cat Dinah, making a chain of spring flowers.

DEFENCE #1: What did you see?

ALICE: A strange sight! It was very curious! A large white rabbit ran by!

DEFENCE #1: Can you describe this rabbit?

ALICE: Yes. He had white gloves, a fan, and the biggest gold watch I have ever seen, on the end of a chain attached to his waistcoat.

DEFENCE #1: Did he say anything?

ALICE: Not to me... but he was muttering something about being late for a very important date!

DEFENCE #1: What happened next?

ALICE: He disappeared down a large rabbit hole under the hedge, and I was so curious I followed him.

DEFENCE #1: Did you find him?

ALICE: NO! We fell down a long tunnel and he disappeared again, through a tiny door. It was too small for me to get through until I found a bottle which said "Drink Me." When I did, I became small enough to get through the door.

DEFENCE #1: Should you have drunk from the bottle, Alice?

ALICE: No... but I didn't mean any harm, and I was so curious!

DEFENCE #1: *(holding up a bottle)* Is this the same bottle?

ALICE: It looks like it. It says "Drink Me."

DEFENCE #1: Your Honour, we would like to have this bottle entered as Exhibit C. *(hands the bottle to Court Clerk then turns to Alice)* Now, Alice, did you intend to bother the citizens of Wonderland?

ALICE: No! I was only asking directions and trying to find White Rabbit. I'm sorry I scared the mice and birds and flowers, and spoiled the Caucus race. If only someone would have told me the rules.

DEFENCE #1: You've heard the testimony of White Rabbit. Did you intend to grow so big that his thatched roof nearly came off?

ALICE: No. I only went upstairs to get his white gloves and fan. I was trying to be helpful.

DEFENCE #1: And, did you intend to eat his special box of Currant Cookies?

ALICE: No... it's just that I was beginning to get so tired and hungry from wandering all over Wonderland!

DEFENCE #1: Why did you run away without apologizing to White Rabbit?

ALICE: I meant to, but I thought he'd be angry with me.

DEFENCE #1: What happened next?

ALICE: I met a Cheshire Cat who had the biggest grin I have ever seen! He gave me directions to March Hare's, because he is a very close relation to White Rabbit.

DEFENCE #1: Did the March Hare tell you which way to go?

ALICE: No. He was too busy having a tea party.

DEFENCE #1: Where did you finally find White Rabbit?

ALICE: I had wandered down a path and found myself in a lovely rose garden, when along came a parade of card soldiers and the Queen of Hearts to play croquet, and much to my surprise, there was White Rabbit! He had been invited to play croquet with the Queen!

DEFENCE #1: In your own words, Alice, tell us what happened at the croquet game.

ALICE: Well, it was very strange! They used flamingos for mallets, and hedgehogs for balls, and there didn't seem to be any rules, as long as the Queen won.

DEFENCE #1: Did you intend to cause a disturbance?

ALICE: No. But my flamingo and hedgehog got away, and the Queen got angry, and all of a sudden I was surrounded by a pack of card soldiers!

DEFENCE #1: What did you do?

ALICE: I tried to push them away, but the Knave of Hearts took me to the Castle and locked me in the tower!

DEFENCE #1: Thank you Alice. No further questions, Your Honour.

(Defence takes his/her seat).

JUDGE: Does the Crown wish to cross-examine this witness?

(Crown rises and approaches the witness stand).

CROWN#1: Yes, Your Honour. Alice, what good is it to say you didn't mean to cause any harm? Don't you agree that if you hadn't been so curious and followed White Rabbit into Wonderland, none of this would have happened?

ALICE: *(sadly)* I try not to be curious, and I give myself very good advice, but I very seldom follow it.

CROWN#1: No further questions, Your Honour.

(Crown takes his/hear seat).

JUDGE: *(to Alice)* You may step down. *(to Defence)* You may call your next witness.

DEFENCE #2: We call Cheshire Cat, your Honour. *(Cheshire Cat takes the stand)*

COURT CLERK/RECORDER: State your name and address.

CESHIRE CAT: Cheshire Cat, Grinning Grove, Wonderland, BC

DEFENCE #2: Do you know Alice?

CESHIRE CAT: I met her in the forest in Wonderland, on April 1st.

DEFENCE #2: What was she doing?

CESHIRE CAT: She was wandering about, looking for White Rabbit, and asking for directions.

DEFENCE #2: What did she say?

CESHIRE CAT: She was very polite, and said "Would you please tell me which way I ought to go from here?"

DEFENCE #2: And what was your answer?

CESHIRE CAT: "That depends on where you want to go." She didn't seem to know, so I gave her directions to March Hare's house, because he is a close relation of White Rabbit's.

DEFENCE #2: Did you like Alice?

CESHIRE CAT: Yes! I thought she was a very polite, well-mannered little girl.

DEFENCE #2: Thank you. No further questions, Your Honour.

JUDGE: *(to Crown)* Do you wish to cross-examine this witness?

CROWN#2: No, Your Honour.

JUDGE: *(To witness)* You may step down. *(to Defence)* You may call your last witness.

DEFENCE #3: We call the Mad Hatter, Your Honour. *(Mad Hatter takes the stand)*

COURT CLERK/RECORDER: State your name and address.

MAD HATTER: Mad Hatter, Tea Cozy Lane, Wonderland, BC

COURT CLERK/RECORDER: Take the Bible in your right hand. Do you swear to tell the truth, the whole truth and nothing but the truth, so help you God?

MAD HATTER: I do.

COURT CLERK/RECORDER: You may be seated.

DEFENCE #3: Mr. Mad Hatter, would you please describe how you met Alice.

MAD HATTER: Certainly. My friends and I, March Hare and Dormouse, were having a tea party on March Hare's front lawn, on April 1.

St, 2017. Suddenly, Alice came out of the woods and sat down at the table with us.

DEFENCE #3: What did she say?

MAD HATTER: She asked March Hare if he'd seen his relation, White Rabbit, but he hadn't.

DEFENCE #3: What did you do then?

MAD HATTER: We decided to celebrate Alice's unbirthday.

Defence: Was she pleased?

MAD HATTER: Well, I think so. She thought it was a curious idea. But then we started telling riddles, and when she realized we didn't know any of the answers, she went off in search of White Rabbit, again.

DEFENCE #3: Did you mind that Alice had joined your tea party without being invited?

MAD HATTER: If she hadn't, how would we have been able to celebrate her unbirthday?

DEFENCE #3: Thank you. No further questions, Your Honour.

(Crown returns to his/her seat).

JUDGE: *(to Crown)* Do you wish to cross-examine this witness?

CROWN#3: Yes, Your Honour. Mr. Mad Hatter, were you giving this tea party?

MAD HATTER: Well, no. It was at the home of March Hare, so I guess it was his party.

CROWN#3: Don't you think it was rather rude for Alice to sit down at a Tea Party to which she hadn't even been invited?

DEFENCE #3: Your Honour, I object!

JUDGE: Objection overruled. Please answer the question.

MAD HATTER: No... we don't have many rules in Wonderland.

CROWN#3: No further questions, You Honour.

JUDGE: *(to Witness)* You may step down.

DEFENCE #3: We rest our case, Your Honour.

JUDGE: *(to Crown and Defence)* You may begin your summations.

DEFENCE #2: Thank you, Your Honour. *(to Jury)*

Ladies and gentlemen of the Jury, we have shown that Alice only followed White Rabbit because she was curious. She did not mean to disturb anyone in Wonderland, and only ate White Rabbit's cookies because she was hungry. Therefore, we can be certain that you will agree that Alice is innocent of both charges, and will find her not guilty.

JUDGE: *(to Defence)* Thank you.

CROWN#2: Thank you, Your Honour. *(to Jury)* Ladies and gentlemen of the Jury, we have shown

that Alice followed White Rabbit into Wonderland, where she had no business going, upset the inhabitants, took food and drink that was not hers, and ruined the Queen of Heart's Croquet Party! She must be taught that it does not pay to be so curious! Therefore, you must find her guilty of both charges!

JUDGE: *(to Crown)* Thank you. *(Jury exits, and votes on all charges based on the evidence. A majority decision is all that is needed. A foreperson is selected to speak for the jury. The Jury returns).*

Madam/Mister Foreperson, have you reached a verdict?

JURY FOREMAN: Yes, Your Honour.

(Alice, the sheriffs and Defence counsel stand).

We, the Jury, find the Accused ("Guilty" or "Not Guilty") of the charge of Disturbing the Peace, and ("Guilty" or "Not Guilty") of the charge of Theft under \$1000.

JUDGE: Thank you. (The Judge then passes sentence of "Guilty" or acquits if "Not Guilty") Court is adjourned.

SHERIFF#1: Order in the court. All rise.
